<b>Item#</b>	<b>QUESTION</b>	<b>ANSWER</b>
<b>1</b>	The Terms of Reference do not mention any need in terms of infrastructure preparation for the GCI. Should we consider this to be outside the scope of the RFP?	Yes, GCI establishment is outside of the scope of this contract. Hence, no infrastructure preparation from the Contractor’s side is required for this project.
<b>2</b>	Several sections of the model of contract included in the RFP is referring to an Annex A which could not be found. Would it be possible to obtain the mentioned annex A?
