The bidder shall include in its quotation documentary evidence of its qualifications to perform the Purchase Order which shall establish to the Commission's satisfaction that the bidder has the financial, technical and production capability necessary to perform the Purchase Order in its entirety and to provide spare parts and other necessary on-going services as required.
3. The bidder shall bear all the costs associated with the preparation and submission of the quotation and the Commission shall not be responsible or liable for those costs, regardless of the conduct or outcome of this RFQ.
4. The bidder's price quotation shall be submitted in the English language, together with relevant technical literatures in duplicate, which shall also be in English.
5. The bidder's quotation shall be typed or written in indelible ink and signed by an official legally authorized to enter into contracts on behalf of their organization. The quotation shall not contain any inter-lineation, erasures or overwriting except as necessary to correct errors made by the bidder, in which case such corrections shall be initialled by the person or persons signing the quotation.
6. The goods and services (if any) to be rendered under the Purchase Order shall have their origin in the States Signatories of the Comprehensive Nuclear-Test-Ban Treaty (CTBT) which is available in the CTBTO website at [www.ctbto.org](http://www.ctbto.org) under [Status of Signatures and Ratifications | CTBTO](http://www.ctbto.org/status-of-signatures-and-ratifications). For purposes of this paragraph, "the origin" means the place from where the materials, goods and/or from which the services are supplied.
7. If such requests are addressed to others or if additional information is obtained from others, it may lead to disqualification of the bidder. 8. From the deadline for submission of quotation until the written notification of award, no bidder shall contact the Commission on any matter relating to its quotation, except when responding to a request from the Commission for clarification. Any effort to influence the Commission in its evaluation of the quotation(s) or its award decision shall result in the rejection of the quotation.
9. The Commission shall evaluate the compliance of the quotation with the RFQ requirements. Subject to its technical compliance, the quotation shall be examined for its contractual compliance and commercial acceptability. Deviation, if any, from the Commission's terms and conditions might be a factor in the decision of award. ## Annex B TERMS OF REFERENCE

### Hotel Services for Integrated Field Exercise (IFE26) in Walvis Bay, Erongo Region, Namibia

#### INTRODUCTION

1. The Preparatory Commission for the Comprehensive Nuclear-Test-Ban Treaty Organization with its headquarters in Vienna (hereinafter referred to as “the Commission”) is the international organization mandated to establish the global verification system foreseen under the Comprehensive Nuclear-Test-Ban Treaty (CTBT), which is the Treaty banning any nuclear weapon test explosion or any other nuclear explosions. The Treaty provides for a global verification regime, including a network of 321 stations worldwide, a communication system, an International Data Centre and On-site Inspections (OSI) to monitor compliance with the Treaty. Further information on CTBTO can be found at <https://www.ctbto.org/>
1. The On-Site Inspection Exercise Programme includes an Integrated Field Exercise (IFE) to be conducted in Republic of Namibia, tentatively between September and November 2026.
2. These Terms of Reference (hereinafter referred to as “ToR”) describe the estimated requirements for hotel services in Walvis Bay (accommodation, catering, meeting facilities, airport transfers) during IFE26, for the Commission. The Contractor(s) shall carry out the Services in accordance with the requirements specified in these ToR in the most cost-effective manner possible.

#### MINIMUM REQUIREMENTS

3. The Commission recognizes that it may be the case that no single potential contractor in Walvis Bay may be able to meet all its requirements outlined in these ToR. Therefore, interested contractors who meet the minimum requirements outlined below are encouraged to submit proposals covering all services they are able to provide, clearly indicating any capacity limitations (e.g., number of rooms available).
4. Contractors should note that:
  - Sub-contracting is permitted under this contract, subject to the sub-contracted facility/service provider also meeting the minimum requirements;
  - The Commission may opt to conclude multiple contracts in order to cumulatively meet its requirements.
